Summer 2020 Operation Procedures

1. Faculty, parents, students will always be required to wear face masks while indoors.
2. Students, faculty and parents will maintain six feet of physical distancing.
3. Building entrance and exit will take place through external doors to individual rooms only. Faculty members will notify you which room the lesson will take place and give directions as needed.
4. Faculty members will take temperatures of students and attendees upon arrival. Students or attendees showing temperatures of 100 degrees or higher will be required return home.
5. Students will not attend the lesson if the student/caregiver has a cough, fever, congestion, etc.
6. Faculty/staff members are the only personnel allowed in hallways. Bathroom usage will be used for emergency only.
7. Water fountains will not be available. Families will be required to bring their own water.
8. Lesson areas will be cleaned regularly by faculty members. The building will be cleaned daily by professional cleaners.
